TERMS OF MEMBERSHIP

1. Membership is open to all current members who are Divisional members of the AERA on the proviso that:
 - Each rider is a current Endurance rider and is not subject to any current disciplinary action or suspension.
 - Riders must be 12 years of age or older in the year of application to the Squad.
2. Only financial Squad members will be eligible for selection at World Championships and World Equestrian Games.
3. Riders must be financial Squad members for a period of 12 months before they can be considered for selection to WC's.
4. Only Squad members will be eligible to represent Australia at World and Continental Championships and Trans Tasman competitions. or any other international competition involving Australian representative Teams
5. Squad members must supply information to the coach/manager on request and on time.
6. Logbook and ride results including vets comments are be submitted to the Squad manager at the time of joining and then all competition results to be updated each year or upon request.
7. Squad members will be required to sign a code of conduct and agreement.
8. A rider profile suitable for media presentation, including a photo should accompany this application.

AES Code of Conduct

1. *As a member of the Australian Endurance Squad, you will be required to conduct yourself in a professional manner at all times. This will include :*
 - a) *Setting a good example in dress and presentation of yourself and your horse/s and associated equipment*
 - b) *Behaving professionally and accepting responsibility for your actions.*
 - c) *Conducting yourself in a professional manner relating to Language, temper, punctuality and truthfulness.*
 - d) *respecting the rights, dignity and worth of fellow Squad members*

2. *Refrain from any behaviour that may bring the AES, AERA and EA and any of the members, associates or affiliated clubs into disrepute this includes interacting with fellow squad members in a dignified and respectful manner and refraining from making statements , publicly or electronically that may be construed as defamatory .*
